





How the Community-Led Local Development approach can help develop the pillars of the EUSAIR.

Mostar (Bosnia Herzegovina) 16-17 July 2019

Background

European policies support Western Balkan countries on their path to EU membership. By translating the enlargement political priorities in key sectors, they provide particularly useful financial assistance to facilitate compliance with accession criteria, including institutional reforms necessary to the the adoption of the *acquis communautaire* and the continuation of negotiations. These priorities are embedded in Indicative strategy papers within the Instrument for Pre-Accession Assistance (IPAII), and are assimilated in the 2030 Agenda for Sustainable Development.

As part of their accession process, WB countries also participate in two EU macro-regional strategies, notably the EU Strategy for the Danube Region (EUSDR) and the European Union's strategy for the Adriatic and Ionian region (EUSAIR). These strategies aim to unite EU Member States and non-EU countries in harnessing their sustainable development potential and in facing common challenges, namely the improvement of transport and energy connections, environmental protection, sustainable tourism and promotion of the blue economy. But are territories prepared to harness such opportunities?

In recent years, local communities have increasingly engaged into cooperation aimed at intra-generational justice, a tendency which is demonstrated by the continuous expansion of associations and volunteering in specific sectors such as: rural economy, civil protection, eco-sustainable tourism, human rights advocacy and democracy.

Local actors need to prepare and be supported in carrying out participatory project-design and management activities aimed at local development, possibly based on a sectoral approach and coherently framed into a sustainable and long-term perspective. In particular, they need support in developing ownership, in achieving synergies with various actors, in avoiding the overlapping of financial instruments and in ensuring efficiency and effectiveness in delivering development policies.

One of the available tools, already applied in contexts such as rural areas of non-EU countries (e.g. southern Albania) with interesting results under Interreg Italy – Austria CBC Programme, is the **Community-Led Local Development (CLLD)** approach. The CLLD methodology is particularly recommended in the official documents of the negotiation process for the 2021-2027 financial programming period as a pathway to participatory local development.

With this two-day seminar the AIE intends to provide target groups with information about financial opportunities and the CLLD approach, together with useful coordination and operation tools. The seminar is very much practice-oriented and uses a mix of short presentations, case studies, group work, simulations, and discussions. Moreover, based on a knowledge-sharing approach, it provides attendees with ready-to-use information and hints.

The seminar is organised in the framework of the Al-NURECC, a joint initiative of the key networks of the Adriatic Ionian regions (<u>CRPM</u>, <u>AIE</u>, <u>Forum AIC</u>, <u>FAIC</u>, <u>UniAdrion</u>), aimed at supporting the implementation and capitalisation of the European Strategy for the Adriatic and Ionian Region (<u>EUSAIR</u>).

In particular, the seminar falls within the AI-NURECC Skills Development action and aims at increasing skills and knowledge of young people and local stakeholders responsible for implementing development strategies on participatory EU project-design and management (Community-Led Local Development approach).

Target Groups

The seminar is best suited to young people, students and young professionals, freelancers, local actors responsible for implementing development strategies including local institutions, educational institutions, intermediate bodies, freelancers, small economic operators, associations and NGOs.

Training objectives

By the end of the Training Action, participants will be able to:

- Identify EU, national and regional programmes/funds/calls and unlock connected opportunities
- Create synergies to harness and capitalise existing projects
- Exchange best practices and network to achieve critical mass
- Examine the CCLD as a possible approach to the development of the pillars of the EUSAIR
