Background

The Adriatic Ionian Euroregion (hereinafter referred as AIE) is an international association for the promotion of trans-national and inter-regional cooperation between regions and local authorities of the Adriatic and Ionian basin. The AIE is implementing the European Territorial Cooperation project called Sustainable Tourism, co-financed by Interreg MED Programme 2014-2020. The aim of the project is to support other projects financed by the cooperation Programme for creating a cluster of initiatives of the sustainable tourism sector in MED area.

In the framework of this project, the AIE needs to acquire ICT equipment for office use. The ICT equipment needed are as follows:

Section 4: Procedure

4.1 Type of procedure

Market search for identify qualified supplier and request for three offers.

The requests of offer/quotation will be sent by AIE to 3 potential ICT good suppliers preselected trough a market research.

The companies have been identified through an exploratory market research conducted via internet, respecting and guaranteeing the principles of transparency, equal treatment, non-discrimination and competition.

4.2 Submission of the offer and quotation

All invited bidders should submit a quotation respecting the following requirements:

How to submit the offer	Companies wishing to respond to this call shall send the offer with a clear description of the ITC goods requested with the economic offer to the following email address: secretariat@adriaticionianeuroregion.eu
Deadline for the offer submission	Service providers companies wishing to respond to the invitation shall send their offers no later than the deadline: 16/03/2020 - by 12:00 a.m. The offers received after the aforementioned deadlines will not be evaluated. The sending of the offer does not in any way constrain the AIE to request the goods in question.
Details of the offer	The offer must be with the indication in figures of the unit prices without VAT and a short description of each items.
Languages in which offers may be submitted	English
Currencies	Euro
Ceiling amounts	The economic offers must not exceed the amount of 1.900,00 € (without VAT)

4.3 Award criteria

Price is the only award criterion. The AIE will evaluate the offers and respective quotations on the basis of the total prices of all items requested. If two or more offers of the same amount will be received, the AIE will contact the bidders and conduct interviews via telephone in order to better evaluate the offers. The results of the selection procedure will be communicated only to the awarded company.

4.4 Invoicing and Payment Conditions

Conditions for the payment:

- Satisfactory acceptance of the goods;
- Submission by the good suppliers of a detailed and correct invoice.

The awarded good suppliers shall invoice to AIE a single invoice specifying the unite prices of each ICT item as well as the total amount.

AIE will pay the provider the total amount of the invoice within 10 days from the reception of the original invoice which have to include the following information:
