Governance and Euro-Mediterranean territorial cooperation

In promoting Euro-Mediterranean relations, the territorial dimension and the creation of spaces conducive to collaboration play a fundamental role. The impact of European policies requires multi-level cooperation between the various actors and at different scales – transnational, cross-border and interregional. The EU is currently engaged in the definition of new governance structures that favour and enhance these spaces which, in the Euro-Mediterranean context, must necessarily be open and transformative.

The integration of the specific objective of governance as a structural priority of the European and Mediterranean territorial cooperation programmes opens up new opportunities for the definition of Euro-Mediterranean alliances. This collaborative governance will provide instruments to strengthen capitalization, synergies and exchanges between institutions, programmes and project communities.

The open approach of governance projects is particularly innovative. On the one hand, it aims to provide adequate responses to the needs of the public and, therefore, to act with the will to have a transformative impact. And on the other, because it opens up the possibility to promote a multi-stakeholder dynamic, which is not only management, but which includes the participation of local, regional, social, public and private agents.

MedCat Partners Forum 2023 will address the following issues:

- What does it mean to talk about governance and what contribution does it have within the framework of European and Euro-Mediterranean territorial cooperation programmes? What does this new axis bring us?
- What alliances between actors and what synergies between projects will this type of governance foster?
- What opportunities open up for the thematic priorities and how are new projects proposed within the framework of the specific governance objective?
